These capacity building seminars have been designed to support the upcoming integrated water management forums (IWM Forums) as part of the implementation of *Water for Victoria*. They will inform, empower and support individuals to work collaboratively within and across organisations to deliver shared-outcomes through place-based integrated planning for water.

What are the seminars about?

The seminars are designed to enhance capacity for Integrated Water Management (IWM) planning within and between organisations in your region; providing a platform to contribute to a shared understanding of IWM, enhance collective knowledge of urban planning and water planning and explore the opportunities for integrated planning to deliver whole-of-community outcomes through how we plan and manage water.

The seminars precede and support the Department of Environment, Land, Water and Planning (DELWP) IWM Forums and will assist practitioners to inform and influence place-based IWM planning. Clearwater are delivering the seminars with support from DELWP.

Who should attend?

We aim to bring together practitioners, senior officers and managers from water corporations and local government, particularly those working in:

- strategic and statutory planning
- stormwater management
- sustainability and liveability
- urban design and landscape architecture
- environment / waterway management
- water / wastewater infrastructure planning
- water / wastewater management (operation and maintenance)

Interactions within and between individuals from different disciplinary and organisational backgrounds, and across different levels of seniority, are important to achieving the seminar objectives.

The seminars are directly related to the IWM Forums, and are therefore reserved for representatives from local government, water corporations and the catchment management authority.
